

## **CENTURY FARM RECOGNITION**

Rural Life Day is an annual diocesan celebration observed on the fourth Wednesday of September. This year the celebration will take place on Friday, October 7 (due to conflicts in the Bishops calendar) and hosted by St. Joseph parish in Menomonie of the Durand Deanery. This is a day to highlight the uniqueness of rural life values and to rejoice in the way that rural life contributes to the Church at large.

As part of this annual celebration, farmers in the Durand Deanery whose farm lands have been in continuous family ownership for 100 years or more will be recognized. All farmers who qualify as Century Farm owners are invited to submit their names for this recognition. A list has been enclosed which names those farms on record with the state of Wisconsin as verified Century Farms.

A 2016 Century Farm application is enclosed. This application can be duplicated or additional applications are available from the Office of Ministries and Social Concerns. The applications are **due** at the address below by **September 1, 2016.**

## **2016 CENTURY FARM APPLICATION**

To qualify as a Century Farm the farm must have been in continuous family ownership for 100 years or more. This continuous ownership of property by the family can be determined from an abstract of title or records such as an original deed. A blood relative of the original owner or a legally adopted child of a descendant must hold the title of the century property.
