### **Celebrating Holy Week Liturgies without a Congregation**

The Holy See has issued general guidelines for the celebrations of Holy Week and the Triduum amidst the COVID-19 pandemic. More specific guidelines will be sent from the Office for Sacred Worship in next week's Chancery Bulletin to pastors to help them celebrate as fittingly as possible Palm Sunday, the Mass of the Lord's Supper, Good Friday, and the Easter Vigil with no or minimal participation by the faithful.

### Virtual Parish Mission for Holy Week and Easter

Most of the faithful will likely be unable to participate in the Holy Week and Triduum liturgies this year because of the restrictions resulting from the coronavirus outbreak. However, the good news is that these sacred events will still be celebrated locally and around the world. Jesus and his Paschal Mystery will be in our midst, and his saving grace will be available to us.

To help the faithful share in this grace, every day from Monday, March 30, through Thursday, April 2, Christopher Carstens will offer a Virtual Parish Mission that uncovers Easter's powerful mysteries. We will travel with Christ from Ash Wednesday through Palm Sunday and look especially at the Triduum's Mass of the Lord's Supper, Good Friday liturgy, and Easter Vigil. In the course of this journey through the highpoint of the Church's sacred year, we will also consider what divine life in God looks like during the Easter season to Pentecost—and beyond.

**UPDATE** - **Electronic Giving option for your parish:** We now have electronic offertory processing for all parishes in place. Parishes that do not already have e-giving options will be given priority. If you are interested in a parish specific encrypted page that will be on the diolc.org domain, please contact us at your earliest convenience.

In the next few days, we will be contacting all parishes and or priests to ensure that online egiving capabilities are functional and accessible.


Once we have your account up running, we will send you your link you can post it to your website or parish Facebook.


- Parishioners will have two options for making a single gift or setting up a reoccurring donation which they can end at any time.
- The Curia Finance Department will process a single check to your parish once a week with a report of parishioners and the parishioners' gross funds received. The gross amounts are the entire contribution that you will add to your Parishsoft records for that parishioner. The parish will be responsible for including the funds on the parishioners' Parishsoft profile and include the proceeds on the parishioners' annual tax statement. This process will allow your parish to process the gift information as you currently do not have any other plate or electronic offertory channel. The recording and depositing of these collections should mirror the process as if an envelope came through the plate collection. We will include their parish of registration if there is one. If they are not your registered parishioners, they should be listed as a "contributor only." If they are non-registered anywhere, it is an excellent time to reach out and stress the importance of registering for your parish.
- We will deduct the processing fees, roughly 3%, on average. The Curia offices will

not charge a processing or handling fee at this time. Our fees may change as we move beyond the pandemic and ascertain the level of effort that is required from us to ensure timely processing. We will notify you of any fee changes before we implement them.

We have also added and are adding links on the <u>Diocesan Parish page</u>, the most visited page of diolc.org. We have a form that lists all 159 parishes so every visitor can support their parish.

As people scroll down to a specific parish, the donation link becomes specific to that parish. The link will take the person to the parish's electronic giving page, whether that is a diolc.org-hosted page or not. You can see the button in the following three images as you would if you drilled down to a specific parish.





We must reiterate our mission every time we ask people to invest with us, as it is the mission their funds are supporting. Remember the adage; without a mission, there is no money, and if there is no money, there is no mission.

Now more than ever, it is time to break through our old fears, habits, and biases to try something new and different to meet parishioners where they are. If we do not stay connected, they, and we, will be lost. To assist you in your communications, we are working on gathering and centralizing a repository of strategies, tips, and sources for your parish communications. This page is to aid you, your parish, and your parishioners to connect and deepen your relationship with each other and bring each of closer to the Lord.

### **7 PRACTICAL STEPS FOR GOING DIGITAL**

With the recent health scare and temporary church closures, many church staffs have an immediate need for enhancements to their Church's digital strategies.

As we saw the wave of church videos posted online this past weekend, we were seeing some missed opportunities while pastors and church leadership scramble to prepare for Sunday. We put together seven practical steps your church and the digital team can use during this time.

**Reminder: Diocesan Annual Appeal**, out of sensitivity parish needs during the current situation; we will delay our next mailing until our communities have had time to process the current environment. Our next mailing was to be in mailboxes the Friday before Holy Week. The target audiences vary by where your parish in comparison to your goal.

If you are at or above your parish goal, we may only mail those who invested last year but have not yet invested this year. (LYBUNTS). If you are below your target, we will be mailing to all those we have registered in your parish and have not given yet this year, whether they have invested in the past or not. (SYBUNTS and Never/New). If your parish would like to include or write their letter to parishioners, please let us know. We will work with you, and the timing as

### 403(b) Retirement Plan

For those affected employees who temporarily have reduced hours (less than 20 hours/week), they should remain in the plan, and contributions should continue based on their actual pay during this time. They would be treated similarly as the school teachers who do not have hours during the summer.

For those who temporarily have no hours and are not receiving any pay, they should be placed on a temporary leave of absence (not noted as terminating employment). They just simply will not receive any contributions during this time since they have no income.

### **Eligibility Threshold for Health Insurance**

St. Ambrose has received questions from both parishes and schools regarding the matter of employees having their hours reduced during this COVID-19 crisis, and the concern of employees falling below the benefit eligibility threshold of 30 hours per week.

It is the interpretation of SAFS that a temporary reduction in hours does not mean the person immediately loses eligibility for the plan. It remains to be determined, at this point, what temporary means and it seems prudent to revisit this matter again in early April. SAFS has requested of our provider their interpretation on this matter and SAFS will communicate their response when received.

Additional questions have been presented regarding positions which are exempt/salaried employees. Does this impact their benefits? Again, it is the interpretation of SAFS that a temporary reduction in hours does not mean the person immediately loses eligibility for the plan.

There is additional consideration with the reduction of hours regarding exempt/salaried

employees. The Fair Labor Standards Act states exempt/salaried employees must earn a minimum of \$684 per week (\$35,568 annually) to maintain exempt status. The calculation for this minimum requirement is based on a look-back period and is a temporary situation, therefore no action is required. If temporary becomes a longer period of time, then additional review would be required.

# The Emergency Paid Sick Leave Act and The Emergency Family and Medical Leave Expansion Act

Congress passed and signed into the law by the President two acts to assist covered employees with paid sick leave and family medical leave. The Office of the General Counsel of the USCCB has provided summaries for these two acts. *Click here* for The Emergency Paid Sick Leave Act and *click here* for The Emergency Family and Medical Leave Expansion Act. The Diocesan Attorney provided a summary of the HR 6201 (Families First Coronavirus Response Act). *Click here* for the summary of HR 6201. After reading the material for HR 6201 you will find that determining eligibility for our employees is difficult. Reimbursement for qualified payments to employees will be offset (reimbursed) through a payroll tax credit refund of the employer portion of FICA and Medicare payments. Any questions regarding the HR 6201 eligibility and application should be directed to James Reider and Father William Dhein for parishes, and Thomas Reichenbacher for schools.

There are additional posting requirements. Employers must post a Secretary of Labor-prepared poster for HR 6201 rights in a conspicuous place in the workplace. These posters should be available by March 25, 2020. Please email or mail a copy to those employees who are working from home or are no longer working.

### **Catholic Mutual Group**

Catholic Mutual has received numerous inquiries from our membership regarding coverage and risk management for the COVID-19 outbreak. Please <u>click here</u> for their communication of current coverage.

With the COVID-19 pandemic, many employees will be working from home. As you know, worker's compensation coverage is in place with Church Mutual Insurance Company, and this coverage does extend to employees working from home for injuries which arise in the course and scope of their employment. Not all injuries at home will be compensable under worker's compensation. For instance, if an employee is making lunch and cuts a finger on a knife, this would not be compensable under worker's compensation. Another example of a noncompensable injury would be a trip or fall in the garage while taking out the garbage. Both of these, and similar injuries, are examples of non-work-related accidents that would be denied. However, when in doubt, always err on the side of caution and report the injury.

Employees who believe they have suffered a work-related injury while working at home must immediately report that injury to their supervisor. After the injury is reported to the supervisor, either the supervisor, the injured employee, or, preferably both, need to report the injury to Church Mutual using the Church Mutual Nurse Hotline at (844) 322-4662 to ensure proper treatment is sought in light of the climate in which we are currently living. *Click here* for the

<u>LogMeIn/GoTo</u> is offering free for 90 days' emergency remote work kits to those who need them. GoToMeeting, GoToWebinar, and LogMeIn Pro are some of the services they are offering. GoToMeeting would allow you to host virtual meetings with up to 300 participants. GoToWebinar would allow you to host a virtual meeting with up to 3,000 attendees. LogMeIn Pro would allow you to log in to your work computer from home.

Through one of our partners, we can place a bulk request for our parishes. Nick Lichter has started out by requesting a few GoToMeeting licenses and a LogMeIn Pro license. Please note, requests will take a couple of days for LogMeIn to fulfill. Zoom.us also offers free licenses for virtual meetings lasting 40 minutes or less.
